Future Energy Week is committed to providing you with the best possible user experience. Future Energy Week is bound by the Privacy Act 1988 (Cth), which sets out many principles concerning the privacy of individuals.

Collection of your personal information

You can view many aspects of the site without providing personal information. However, for access to future Future Energy Week support, some features require you to submit personally identifiable information. This may include but is not limited to your name, phone number and email address.

Google Analytics

This site uses Google Analytics to provide a better experience to its users, by aggregating data that helps us to provide more relevant advertising and content. Google Analytics will associate the visitation information it collects from this site with Google information from accounts of signed-in users who have consented to this association for the purpose of ad personalisation. This Google information may include end user location, search history, YouTube history, and data from sites that partner with Google—and is used to provide aggregated and anonymised

insights into users' cross-device behaviours to provide more relevant information to users. Google users may access and/or delete their data via [My Activity](#).

Typeform

SendGrid

The Site uses Twilio's SendGrid to securely forward information from our contact forms to our support team. SendGrid's privacy policy can be found [here](#).

Google reCAPTCHA

The Site's contact forms use Google's reCAPTCHA service to reduce spam and abuse. reCAPTCHA sets a necessary cookie (`_GRECAPTCHA`) when executed for the purpose of providing its risk analysis. Google's privacy policy can be found [here](#).

Sharing of your personal information

We may occasionally hire other companies or organisations to provide services on our behalf, including but not limited to handling support enquiries, processing transactions, and providing event registrations. Use of your personal information
